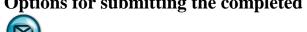
Completing the proxy form:

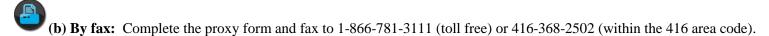

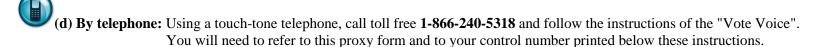
