Strathcona refinery works directly with contractors who provide a variety of services including: mechanical, scaffolding, civil, electrical, instrumentation, inspection, insulation, tank, industrial cleaning, catalyst handling, offsite fabrication, refractory, machinist, equipment mechanics, cranes, and equipment rental services.

Strathcona refinery direct purchases materials from both local and global suppliers. Purchases include: gaskets, bolts, electrical, tools, pipe, valves, fittings, flanges, catalysts, chemicals, motors, compressors, pumps, exchangers, furnace, boiler, tanks, towers, drums, and reactors.

Strathcona refinery has a preference for long term (typically 5 year) agreements with our suppliers and contractors. Preference is given to companies with proven industrial capabilities specifically in refining.

Strathcona refinery bundles and unbundles materials and services to meet our strategic needs. For example scaffold and insulation services may be bundled or unbundled in an agreement.

Strathcona refinery is open to labour from a variety of work force sources including union and non-union.
